Titus 3:4-7; Luke 24:46-47; Ephesians 2:8-9; John 14:6; Acts 4:12, Romans 3:23, Romans 5:12, Romans 6:23.
- We believe in the present ministry of the Holy Spirit who imparts spiritual gifts as He chooses and whose indwelling enables the Christian to live a godly life. Galatians 5:16-18; Romans 8:9.
- We believe in the resurrection of both the saved and the lost; the saved unto the resurrection of eternal life and the lost unto the resurrection of damnation and eternal punishment in the Lake of Fire. Revelation 20:11-15; I Corinthians 15:51-57.
